

### **NEMONT PHOTO CONTEST RULES**

Please read these rules (the Rules) before submitting your photo(s) to Nemont's photo contest. These are General Rules governing all contests hosted by Nemont, unless so specified in the Specific Rules that may be applicable to individual contests. By participating in the contests, you understand, acknowledge and unconditionally agree to abide by the following Rules:

### **BASIC SUBMISSIONS GUIDELINES FOR PHOTOGRAPHS**

- 1. The contest is open to Nemont customers only.
- 2. Submissions will not be accepted once the deadline lapses.
- 3. Photos submitted must be high quality photos. Some smartphone photos don't make the cut depending on lighting. They look smudged or pixelated.
- 4. You may submit as many entries as you wish.
- 5. You are required to provide a unique title & description for each image submitted.
- 6. Photos that have not won previously may be submitted again.
- 7. All submitted photos must not have border(s), logo(s), copyright marks, identifying marks, or any other visible references and/or marks on the image.
- 8. Basic editing, including color enhancement, the use of filters, and cropping of the Photo(s) is acceptable, provided any such editing does not affect the authenticity and/or genuineness of the Photo(s).
- 9. Advanced editing used to create illusions, deceptions and/or manipulations, and the adding and removing of significant elements within the frame is prohibited.

## THE JUDGING

- 1. Nemont will appoint judges for the contest. This will comprise of members of the editorial team and / or external judges.
- 2. The judging panel shall assess and determine the winning Photos. The results and the winners will be emailed a release agreement that must be filled out and sent back as soon as possible.
- 3. The decision of Nemont's judging panel will be final and binding on all Participants in respect to all matters relating to the Contest.

# **THE PRIZES**

- 1. A \$50 bill credit will be awarded to the photographer that has the photo chosen for the Calendar cover, Phone directory and large Wall calendar.
- 2. A \$25 bill credit will be awarded to the photographers that has a photo chosen for the calendar.

# **INTELLECTUAL PROPERTY RIGHTS**

- 1. Submitted photos must be original, created and/or taken by the contestant. It must not contain any materials owned or controlled by a third party for which you have not obtained a license, must not infringe the copyright, trademark, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity.
- 2. Nemont respects photographers' copyrights and copyrights shall remain vested with the creator of the image. Upon making the submission, you grant Nemont, worldwide, non-exclusive, royalty free, sub-licensable right and license to use, publish, reproduce, display, perform, adapt, create derivative works, distribute, have distributed, print, in whole or in part, in any form, in all media forms now or hereafter known, to promote the contest, image, the photographer or for editorial or educative use.
- 3. The Photographer will be credited wherever the image is used.
